

5. Specification / model: Replacement of asbestos roofing with terracotta roof tiles and replacement of false ceiling with wooden board (Details of work are attached as Annexure-I)

8. Pre-qualification: Bid is open only to firms who have carried out similar works for reputed clients and can provide adequate reference to that effect. Bid may be tendered in local currency.
9. Conditions:
 - (i) The Tender should be valid for not less than three months. It would be subject to availability of funds for this purpose.
 - (ii) Two Bid System (Financial & Technical Bids): Bids should be put in two separate covers placed in one larger envelope along with Demand Draft of 2% of cost estimated of the replacement of asbestos as Ernest Money Deposit (EMD) in the name of High Commission of India, Accra.
 - (iii) The tender issuing authority reserves the right to withdraw/cancel the Tender for any reason whatsoever after publication/award of the contract.
 - (iv) Payments/Bills would be settled after completion of the awarded work and 10% of the total amount which would be released after six months of the completion of the work. All payments would be made by cheque only after satisfactory completion of work.

Following details of replacement of asbestos roofing and false ceiling work at India House, at No.1 Jawaharlal Nehru Road, Cantonments, Accra, Ghana

1. Removal of asbestos roofing of main building of India House.
2. Removal asbestos roofing of servant's quarters.
3. Removal of asbestos roofing of office of Security Assistant.
4. Removal of asbestos roofing of Guard rooms.
5. These asbestos roofing need to be replaced with terracotta roof tiles.
6. False ceiling will be replaced with wooden board.
7. Approximately the area is 1100 sqmeters.
